



**NOTICE INVITING EXPRESSION OF INTEREST FOR RUNNING COMMUNITY DEVELOPMENT CENTRES THE REMOTE AREAS OF KUMARGRAM AND KALCHINI BLOCKS**

Expression of Interest is invited from bonafide/ registered NGOs, including Tea Garden Hospitals/Charitable hospitals with requisite infrastructure, qualified human resource and experience in Basic Emergency Obstetric Care to run Community Development Centres (CDCs) in the remote areas of Kumargram block of Alipurduar district.

**Preamble:**

Increasing access to Basic Emergency Obstetric Care (BEmOC) services and Skilled Birth Attendance in the remote areas is a part of Government of West Bengal's strategy to reduce maternal mortality and morbidity under the RCH-II/NHM Programme. In this context, the government has laid emphasis on increasing number of institutional deliveries especially in hard to reach areas of the state. To address this issue the state has taken an initiative to create Community Development Centres (CDCs) in remote areas involving Non-Government Organizations (NGOs) through the Public Private Partnership (PPP) mode

**Deliverables:**

**Antenatal care:** Ensure Ante-Natal Care and related services including administration of Injection Tetanus Toxoid, Iron and Folic Acid tablets, basic laboratory tests such as Pregnancy test, blood for haemoglobin, urine for sugar and albumin and referral for other investigations as required.

**Intra Natal Care:** Ensure care during labour, delivery and after delivery by a Skilled Birth Attendant (Medical Officer or Staff Nurse), management of labour and conduction of safe deliver as per the Standard Labour Room protocol of the state.

**Essential New Born Care:** Ensure Provision of warmth and prevention of Hypothermia and prevention of infection, as well as, basic new born resuscitation, early breast feeding and weighing the neonates

**Post Natal Care:** Ensure 48 hours stay after delivery and ensure provision of all services related to post natal care, including check-ups and advice for both mother and child

**Free drugs and transportation:** Ensure fully cashless delivery services and transportation services for brining the mother to the hospital and back home, as well as, referral to higher centres utilizing the 'Nischay yan'.
