Expression of Interest is invited from registered and credible **NGO/CBO with** requisite credentials by calling Expression of Interest (EOI) for operationalization of the 24 hours mortuary van services in Alipurduar district.

Preamble:

- 1. The Operationalization of the vehicle is proposed to be outsourced to any credible NGO/CBO with requisite credentials by calling Expression of Interest (EOI)
- 2. The Outsourced agency is proposed to hire a driver
- 3. The vehicle would be placed 24 X 7 X 365 days
- 4. The onus of payment of salary to the driver and support staff and maintenance of the vehicle and the medical gadgets/equipments would be that of the outsourced agency.
- 5. The NGOs/CBO/Trust/etc will be entitled to collect and retain user charges @Rs.500/(Rupees Five Hundred only) as base hire price within Alipurduar Municipality area up to 10
 kilometers and Rs.5.00 (Rupees Five only) per additional kilometer in excess of 10 kilometers.

 These charges can be used to meet expenditures related to operation, maintenance and management
 of the dead body carriage van and the gadgets/equipments fitted on it. Money Receipt
 (Annexure/SOP-4) must be issued against receipt of user charges.
- 6. Display of the rates will be done at the NGO/CBO premises
- 7. The agency will have to maintain a log book, which has to be authenticated by the appropriate authority of the agency
- 8. The vehicle is to be used only for deceased transport and would be available within 1 (one) hour of requisition
- 9. The proceeds of the revenue earned shall be that of the agency concerned, which is to be utilized for the salary of the staff, maintenance of the vehicle and the gadgets/equipments
- 10. Printed money receipts will have to be provided to the beneficiaries/clients and a counterfoil kept for record and maintenance of the accounts, which will be subject to verification by the DH&FWS, Alipurduar from time to time.

11. Registration:

a) NGO/CBO should be registered under the Societies Registration Act/Indian Trust Act/ Indian Religious and Charitable Act/Companies Act or the State counterparts of such acts for more than three years.

- b) **NGO/CBO** applying for projects in a State other than that of its registration should State specific chapters registered. Alternately, branches affiliated to a national federation / organization can be registered with the parent body.
- c) NGO/CBO should preferably have office premises in Alipurduar town.

12. Financial:

- a) Annual turnover of at least Rs.2.00 lakhs for district level projects is preferable
- b) The NGO/CBO should preferably have good financial stability, having infrastructure in shape of land, building or corpus fund amounting to Rs.2.00 lakhs for NGO/CBOs applying for projects at the district level respectively in the name of the organization.

c) Criteria for selection of the NGO/CBO:

- o Registered under the West Bengal Society's Act
- o Bank guarantee of at least Rs. 1 lakh
- o Experience in the field of Health Care Delivery/Social Sector
- Hired/Rented Office Premises

d) Procedure for selection:

The committee under guidance of the Chief Medical Officer of Health, Alipurduar shall be the authority, which would select and appoint NGO/CBOs at the district level.

Committee constituted under the Chief Medical Officer of Health, Alipurduar would be responsible for selection of NGO/CBO in the district.
