



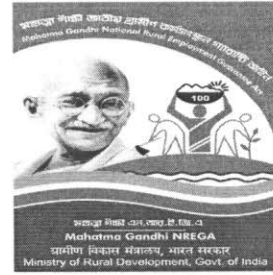



It is unfortunate to note that even after making several requests regarding the uploading of Aadhaar Number/Enrolment Number in MIS, the latest figure of uploading status is found very alarming for our District in MIS. In our District of Jalpaiguri, till date only 11567 no. of Aadhaar card numbers have been incorporated in MIS out of total registered 1544167 persons and 683376 Household. The Block wise no. of registered persons, Aadhaar card is attached herewith.

The Uploading of Aadhaar/Enrolment Number in MIS is very important and the process has to be completed within 31 July'2014.

So you are once again requested to look into the matter and take necessary action to speed up the process of uploading of Aadhaar/Enrolment Number in MIS of all the PIAs' under your jurisdiction immediately so that the process may complete within the mentioned time.
